# 5.0 Executive Director's Report to the Board

Executive Director's Report to the Board is accepted.

A&A Trading Log Marketing Team introduces and presents to the Board: John Mohammed – President and owner, Stan Johnson – General Manager, Dave Marquis - Forester, Braydon

Company Overview presented by JH - Points discussed include: has their own tenure in addition to managing others, logging company, ten active partnerships with First Nations, well developed relationships with global customers gives a good understanding of market trends, custom cut market, mixed booms turn over inventory faster. Services offered include Forest Management, Timber Marketing, Financing, Business Development, Policy and Relations Support, Grant and Funding support, Project Management, Trusted Advisory, involved with lobbying bodies such as COFI, private ownership allows for long-term planning, quality control reports back to contractors to maximize value.

Questions: Transporting logs from Sechelt Peninsula – Carlson Dump and towing or dryland sorts on Howe Sound, discussion of local selling priorities, Why the Community Forest? - operating in the area anyway and wants to be part of the community.

Market Report presented by Stan Johnson – Points discussed include: networking to stay current with the market, negotiating best value for logs, housing starts in US driving the market last year slowed down with interest rates rising, log prices have levelled off and demand continues for most species and sorts and stable pricing. With summer shutdowns for heat/drought turning quickly into winter shutdowns for snow, winter market for the Community Forest timber profile is strong with strong pricing for fir and cedar poles, and even hemlock seeing an increase in recent weeks. Export market still impacted by covid lockdowns decreasing mill capacity, competition from European glulam products and Japanese post-war stand regen.
