MESSAGE FROM THE CHAIR

In 2023 we built upon the foundation laid in the last two transformative years, continuing our commitment to ecosystem based management and community engagement, and making substantial progress towards our strategic objectives.

Some of the key accomplishments over the past year include:

- Conducting landscape-wide inventories to identify and classify ecosystems;
- Establishing recruitment areas for future old-growth forests
- Continuing to fund and support wetland restorations projects
- Initiating hydrology assessments of important watersheds
- Establishing conservation areas within our tenure to enhance ecological resilience.

In Addition to these conservation-focused efforts, we have moved forward with operational initiatives that balance ecological responsibility with economic sustainability. These include:

- Introducing alternative harvest methods like single-stem and commercial thinning into our operating plan
- Initiating wildfire risk mitigation planning
- Longer-term fiscal planning to support our strategic goals.



The corresponding themes of environmental protection and fiscal management throughout our activities this year are reflected in two significant decisions.. In November 2023, the Board of Directors passed significant resolutions that reinforce our commitment to responsible forest management. One of these resolutions was the voluntary reduction of our Annual Allowable Cut (AAC) from 20,000m³ to 15,000m³, a decision that underscores our dedication to long-term sustainability. Another resolution was to cease the extraordinary dividend, ensuring that future earnings are reinvested directly into the Community Forest to support EBM values and stewardship initiatives. Importantly, the Board's commitment to the regular dividend remains unchanged, continuing to provide a re-turn on the original investment.

Our commitment to community engagement remains steadfast. Over the past year, we have undertaken a comprehensive inventory of recreational uses within our tenure, supported the construction of kiosks, improved road maintenance, and enhanced site development—initiatives that contribute to responsible and accessible forest use. For example, we continue to provide wood for bridgebuilding projects and maintain a successful firewood program, which facilitates legal access to firewood, reduces tree poaching, and ensures free split and delivered firewood for community members in need.

Another area of focus is our exploration of carbon projects. While this is a complex and evolving field, our Managing Forester and one of our Directors have completed a Micro-Certificate in Carbon Projects, equipping the Community Forest with valuable expertise to navigate and benefit from emerging opportunities in carbon management.

Our community engagement efforts continue to evolve and expand. We have strengthened our outreach through communi-

Meeting regularly, this group effectively represents a broad cross-section of professionals and community members, ensuring diverse perspectives inform our work including informed perspectives from the conservation community.

Finally, I would like to take a moment to recognize and congratulate our Lead Ecologist, Laurie Kremsater, on receiving the Distinguished Forest Professional Award earlier this year. This prestigious honor is the highest recognition in the field, celebrating outstanding service and significant contributions to the advancement of forestry throughout a career. We are fortunate to have her expertise guiding our ecological stewardship.

In closing, I extend my sincere gratitude to our volunteer Board of Directors, our exceptional staff, the Community Advisory Panel, and our supportive shareholder. It takes a dedicated team and an engaged community to turn aspirations into reality, and I am proud of what we have accomplished together. As we look ahead, we remain committed to responsible forest management that balances ecological integrity, community benefit, and long-term sustainability.

2023 LEGACY FUND GRANTS

The Sunshine Coast Community Forest has paid over \$4 million in dividends to the District of Sechelt since they created the Sunshine Coast Community Forest Legacy Fund in 2014. A portion of those contributions are available for your community projects, and a portion remains in this fund held by the District of Sechelt for future community benefit. Thsee are your projects that received grants in 2023.

Pender Harbour Community School

Completion costs for new community building - \$30,000 Pender Harbour Community School offers learning, mental health support, recreation, and other essential programs. Many services would be otherwise inaccessible due to transportation barriers. Funds will cover final costs for major building upgrades started in 2022, including foundation work, ramps, stairs, electrical, and plumbing.

Sunshine Coast Salmonid Enhancement Society Repair of water source pipes - \$30,000

Chapman Creek Hatchery, run by the SC Salmonid Enhancement Society, supports local salmon stocks. The water source pipe is leaking, raising water levels in the parking lot and risking supply failure for incubating eggs and fry. A stop log gate is also needed to regulate water flow during repairs or emergencies.

Tetrahedron Outdoor Club

New bridge over Chapman Creek - \$30,000

The Tetrahedron Outdoor Club promotes outdoor recreation and stewards Tetrahedron Park, used by thousands of hikers. The Chapman Creek bridge, vital for backcountry access, is deteriorating and unsafe. Funds will help replace it with a secure 44-foot aluminum bridge.

BC Conservation Foundation

Scientific lab equipment for kelp nursery - \$30,000

The BC Conservation Foundation conserves fish and wildlife resources. Kelp beds in the Sunshine Coast and Salish Sea have declined by 90%, threatening marine habitats. To support restoration, funds will equip a kelp nursery with lab equipment for cultivating and planting kelp.
